

**AN ORDINANCE AMENDING  
THE DEVELOPMENT REGULATIONS OF THE CITY OF BYRAM**

**WHEREAS**, the City of Byram has in place certain Development Regulations adopted by the Board of Aldermen by Ordinance on or about March 11, 2010; and

**WHEREAS**, the Development Regulations of the City of Byram contain certain requirements which must be met before storm drain infrastructure is accepted for maintenance by the City of Byram; and

**WHEREAS**, the City of Byram believes the City and the public at large would benefit from additional storm drain standards in place within Article IV, Section 410 of the Development Regulations before the City accepts for maintenance storm drain infrastructure;

**THEREFORE, BE IT ORDAINED** by the Mayor and Board of Aldermen of Byram, Mississippi, that the City of Byram's Development Regulations, Article IV, Section 410 be amended to include the following language:

**410.03 Inspection and acceptance:** Prior to acceptance by the City of Byram and after all underground facilities are installed, at the expense of the developer, a CCTV video inspection shall be performed by an approved CCTV Inspection Company. Any construction debris found shall be removed and any separated joints, misaligned pipe or any other defects which may be found shall be corrected by the contractor prior to formal acceptance by the City of Byram. The inspection firm shall provide the City with two full versions of a detailed report of the inspection. The report shall include two printed and bound color copies of the report and two electronic copies in PDF FORMAT as well. If any defects are found, a post-correction inspection will be required as well. The report format and variance classifications shall follow NASSCO PACP standards.

This Ordinance, having been adopted, shall be in force and effective in thirty (30) days of this date.

**ORDAINED, ADOPTED AND APPROVED** by the Mayor and Board of Aldermen of the City of Byram, Hinds County, Mississippi at its regular meeting held on the 12th day of May, 2016.
